Please pre-register -- it makes life easier for everyone.

RACE DESCRIPTION: This is a hilly and technical course -- hardly a flat place anywhere on the course. Challenging but great fun. Riders will be doing multiple laps, actual number of laps will be announced morning of. Registration opens at 8:00 AM.

DIRECTIONS: Lake Sonoma is about an hour and a half north of San Francisco, about 14 miles west of the city of Healdsburg. Take Highway 101 north to the Dry Creek Road exit at Healdsburg and make a left (heading west). Follow Dry Creek Road for approximately 10 miles until it makes a 90-degree turn at the base of the Lake Sonoma dam and becomes Stewards Point/Skaggs Springs Road. Stay on this road up the hill to the bridge. Two miles past the bridge, you will see a sign and the road for Liberty Glen Campground, which you will make a left into. Follow that down, then when the road "Y"s after the tollbooth, go to the left. Follow that about an 1/8th of a mile to Campground "E".

CONSENT AND RELEASE OF PARENT OR GUARDIAN

I accept responsibility for the condition and adequacy of my competition equipment. I will compete wearing a helmet which satisfies the requirements of the Releasees' Racing Rules or Regulations and that can protect against serious head injury, and assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which to my knowledge, would endanger myself or others if I participate in this event, or would interfere with my ability to participate in this event. I understand that drug testing may be conducted for athletes registered for this event and that the use of blood boosting or substances prohibited by Releasees' rules would make me subject to penalties including, but not limited to, disqualification and suspension. I agree to be subject to drug testing if selected, and its penalties if I fail to comply with the testing or am found positive for the use of a banned substance. I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert a claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in successfully defending. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any subsequent waiver or modification. I consent to the release by any third party to Releasees and their insurance carriers of my name and medical information that may relate solely to any injury or death I may suffer arising from the event. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and the sponsors of this event, the organizer and any promoting organizations, property owners, law enforcement
